manne	ninor penalty is assessed to B12 for tripping. B12 disputes the call in an unsportsmanlike er. B23 also reacts poorly to the tripping call and disputes the call in an unsportsmanlike er. SRD



5. A player is identified as wearing his helmet and/or facial protector in an offset position during play. SRD
6. In a Senior game, a player high sticks the puck and then on the follow through hits an opposing player above the normal height of the shoulders. No injury results. SRD
7. At 6:00, A3 is assessed a double minor penalty for head contact. Team B scores at 5:00. Before play resumes, B7 is assessed a minor penalty. Are the minor penalties considered coincidental and what is the on ice strength for each team when play resumes? SRD
8. The referee has assessed a minor penalty for charging and it has been announced as a minor penalty. Before the play resumes, the referee realizes the penalized player has injured her opponent. SRD
9. An identifiable player or team official sprays water out of a drinking bottle on a linesman. SRD
10. A player is on a breakaway with the opposing goaltender in the net when the buzzer sounds causing a stoppage of play. The buzzer sounding was caused by a malfunction or timekeeper error. There was sufficient time left in the period for the breakaway to have been completed. SRD
11. What criteria must be met before the referee can award a penalty shot instead of a minor penalty for tripping? SRD
12. An alternate captain leaves her players' bench to discuss a call with the referee. SRD



13. With 1:20 remaining in the third period, A10 and B12 are assessed coincidental minor penalties and are sent to their respective dressing rooms. With three seconds left in the game, a fight breaks out on the ice and B12 returns to the ice and becomes involved in the fight. B12 was the only player to come onto the ice. What penalties are assessed to B12? SRD
14. A player on the ice throws her stick to a teammate who is also on the ice. The player picks up the stick that was thrown by her teammate. SRD
15. A goaltender intentionally knocks the net off its moorings as she leaves the goal crease to go to her bench to be substituted by another player. The referee has observed this action. SRD
16. A goaltender goes to the players' bench during a stoppage of play for a replacement of her stick. SRD
17. On a penalty shot, the goaltender poke-checks the puck as the attacking player approaches the net. The puck bounces past the goaltender towards the net. The attacking player regains possession and control of the puck and directs it into the net. SRD with an explanation for the call.
18. The Team A goaltender has been removed from the ice. A Team B player attempts a wrap around shot at the open Team A net; however, he is prevented from scoring by snow that the goaltender piled against the side of the net. SRD
19. A linesman observes an infraction calling for a double minor penalty. What action does he take? SRD

20. After the game, the officials are in their dressing room when the losing coach asks to speak to the referee. He points out that one of the opposing players had received three stick infractions but no game ejection was assessed. This player assisted on the winning goal. SRD
21. A team official attempts to head-butt an opposing player but no injury results. SRD
22. A player reacts to verbal harassment by going into the stands to confront a spectator who was harassing him. SRD
23. A6 is in his defending zone and shoots a broken stick at an opposing player. The shot stick hits the opponent or interferes with his progress. SRD
24. An attacking player charges the opposing goaltender while the goaltender is standing in her crease. SRD
25. In a Junior game, the goaltender makes contact with an opponent's head. List 5 possible outcomes. SRD
26. Two players are fighting on the ice close to the players' bench. A player on the bench intervenes in the fight as a peacemaker. What penalties are assessed to the player on the bench? SRD
27. The goaltender has been removed and an opposing player gains possession and control of the puck on a breakaway in the neutral or attacking zone. The puck is knocked off her stick by a stick thrown by a defending player. The attacking player could regain possession of the puck easily. SRD



- **28.** Two willing combatants square off to fight. The player from Team A knocks the Team B player down with the first punch. SRD
- **29.** An attacking player is tripped by a defending player. As the attacking player falls, she makes no attempt to avoid contact with the goaltender and the goaltender is knocked to the ice. The attacking team scores. SRD
- **30.** Play is in Team A's defending zone as the buzzer sounds to end the game. The players from Team A leave the players' bench to congratulate their teammates without being directed off the bench by the referee. The Team B players remain on their bench. As the players of Team A are skating to their goaltender, a player from Team B, who was on the ice at the end of the game, punches a Team A player and is assessed a roughing penalty. SRD
- **31.** A player enters the game illegally from the penalty bench due to the timekeeper's error. She checks an opposing player who has a breakaway in the neutral or attacking zone. SRD
- **32.** A player who is about to come onto the ice on a legal line change plays the puck with her stick when one of her skates is still on the players' bench. SRD
- **33.** On a stoppage of play, A8 comes off his bench on a legal line change. Before play resumes, he is involved in a fight with B6 who was on the ice when the stoppage of play occurred. Both players fight but neither is identified as the instigator. What penalties are assessed to A8 and B6? SRD
- **34.** An attacking player is assessed a penalty in her attacking zone, thereby forcing the face-off to the neutral zone. Before play resumes, a player of the defending team is assessed a penalty. Where does the face-off take place? SRD



- **35.** The goaltender is on the ice, but away from his goal crease. A player of the opposing team takes possession and control of the puck and shoots it towards the net. As the puck is about to enter the net, a defending player knocks the net off its moorings. SRD
- **36.** During a face-off, a defending player makes physical contact with his opponent resulting in a minor penalty being called before the play commences. The on ice strength goes from 5 on 4 to 4 on 4. Which team or teams can now make a line change? SRD
- **37.** Player A10 has dropped his broken stick. As he skates by the penalty box, A12 who is serving a misconduct penalty throws his stick to A10 who picks it up from the ice and participates in the play. SRD
- **38.** Team A pulls their goaltender for an extra attacker. The play comes back into Team A's defending zone. A Team B player takes a shot at Team A's net. The puck is stopped and drops to the ice in the goal crease. A Team A player deliberately falls on the puck causing a stoppage of play. SRD
- **39.** A goal is scored. On checking, the referee is notified that the clock had stopped and was not running at the time of the goal. SRD
- **40.** All penalties are assessed on the same stoppage of play. Identify: the time penalties to be served, the on ice strength of each team and the player/players serving the time penalty/penalties. SRD

41. Team A shoots the puck at the Team B net. The puck enters the net but immediately bounces out again without the referee seeing the goal; however, it is observed by a linesman. Play continues and Team B scores to cause the first stoppage of play. SRD



- **42.** A Team B player has possession and control of the puck in the neutral zone just outside her defending blue line. She shoots the puck towards the Team A net. The puck goes directly out of bounds into the mesh behind the Team A net. Where is the ensuing faceoff? SRD
- **43.** An attacking player attempts to kick a stick that is lying on the ice back to her teammate. After being kicked, the stick hits the puck and the puck goes directly into the net. SRD
- **44.** A delayed offside is signalled by the linesman. Attacking players A5 and A8 leave the attacking zone into the neutral zone (tag up). Attacking player A10 leaves the ice inside the attacking zone and goes into his players' bench. The puck is still in the attacking zone. SRD
- **45.** All penalties are assessed on the same stoppage of play. Identify: the time penalties to be served, the on ice strength of each team and the player/players serving the time penalty/penalties. SRD
