Certificate of Insurance BFL Canada User Guide

Hockey Canada has teamed up with BFL Canada to provide an online Certificate of Insurance platform.

The following information is required to pursue a certificate of insurance:

- Name and address of the entity requesting the proof of insurance coverage
- Name and address of premises you will be occupying
- Type of event being conducted on those premises
- Date of event
- Copy of contract you are being requested to sign for use of that facility

If the above information is not presented, the request may be declined and you will be required to resubmit the request with the missing information. Please allow up to ten (10) business days for processing.
